

Society Board and Crosby Township Trustees Working on a Lease Agreement

For nearly two decades, the Society has had a verbal agreement with the Crosby Township Trustees that allowed the Society to use the Old Town Hall as a place to have a museum and store historical items. Two years ago the Society, with the permission of the Trustees, began renovating the hall. Because of the work being done by Society volunteers and the money that is being procured to renovate this historical building, the Board thought it wise to have more than a verbal agreement. Thus, the Board has been working with the township attorney to form a lease contract that spans fifty years with the option to renew after that period. This contract will be specific as to the responsibilities of both parties. When the lease is finished and signed, it will be available for Society members to peruse.
